The C-A-B Sequence of CPR

The 5-Link Chain of Survival

Simplified Adult CPR

- Emphasis on effective chest compressions
- Hands-only or compressions without ventilation
- 30:2 compression-ventilation ratio for all lone rescuers
- Checking breathing/no breathing in unresponsive adults
- Rescue breathing
- The jaw thrust technique
- Mouth-to-mask or bag-mask for rescue breathing
- Two-rescuer CPR
- Proper use of AED for adult victims

Adult Choking

Child and Infant BLS for Health Care Professionals teaches:

- 1 or 2 hands for child chest compressions
- Two thumb-encircling hand technique for infant compressions
- Effective rescue breathing
- Two-rescuer CPR
- 15:2 ratio for infant/child 2-rescuer CPR
- Proper use of AED for child victims
